Rental Protection Plan

The Rental Protection Plan (RPP) is a simple, affordable, and smart way to protect yourself from the unforeseen. Doodie Calls, Inc. offers a program to provide you with added protection for the most common problems:

- Accidental damage to Doodie Calls, Inc. property
- Theft of Doodie Calls, Inc. property
- Loss due to fire, earthquake, hail, wind, and all other forces of nature

How Does Our RPP Work?

RPP limits your exposure when an authorized user incurs unintentional damage, loss, or theft to Doodie Calls, Inc.'s rental property. RPP is not insurance; it is an option that Doodie Calls, Inc. offers to limit your liability for loss or damage to the property you have rented. You may purchase RPP for 10% of the rental fee. If your rental is for more than one invoice period, the fee is 10% per invoice. If a covered loss occurs, Doodie Calls, Inc. will cover the costs of repair and/or replacement.

Customer's General Responsibility

Under the Doodie Calls, Inc. Rental Contract, the Customer renting the property is responsible to Doodie Calls, Inc. for all loss of or damage to the rented property and for its return in the same condition it was received. The Customer is responsible for the care and safekeeping of the rental property from the time of delivery until retrieval by Doodie Calls, Inc. The Customer agrees that it will use its best efforts to protect the property from loss, theft, or damage at all times during the rental period and until the property is retrieved by Doodie Calls, Inc. If you comply with this agreement, the rental contract, and if you have accepted the RPP, then Doodie Calls, Inc. agrees to waive your responsibility for loss of or damage to the rented property.

What the RPP Does Not Cover

Notwithstanding your acceptance of the RPP, your responsibility for loss of or damage to the rented property will not be waived if such loss or damage results from

- Negligence
- Misuse or abuse of the property
- Exposure to corrosive materials
- Vandalism, malicious mischief, theft, or conversion of the property **unless** an authorized person promptly files with the applicable public authorities a formal written theft, vandalism, or conversion report and promptly provides notice to Doodie Calls, Inc. by filling out one of our RPP Incident Reports
- Your failure to perform any of your obligations under this agreement

In the event of loss of or damage to the rented property, you are required to cooperate with Doodie Calls, Inc.'s investigation of any incident involving the property.

Opting In or Opting Out of the RPP

The RPP is optional, and you need not accept it. However, **if you choose to opt out of the RPP, you must maintain insurance coverage and provide your certificate of insurance to Doodie Calls, Inc.** If your insurance coverage expires or is unacceptable to Doodie Calls, Inc., you agree that Doodie Calls, Inc. may charge the RPP for your rentals until such time as you provide an acceptable and valid certificate of insurance. If this form is accompanied by a quote and you choose a different option on the quote than you do below, the option you choose on the quote will take precedence.

At this time, you choose to:

- Opt in to the RPP for this order and all future orders you place to limit your liability for loss of or damage to the rented property. *(If you wish to change this in the future, you must submit a request in writing to Doodie Calls, Inc.)*
- Opt out of the RPP and accept full liability for loss of or damage to the rented property and agree to provide Doodie Calls, Inc. with an acceptable and valid certificate of insurance.
